Mark Moore was in attendance to report on his progress with the ROSPA report, as follows:-Framfield

- The junior swing chains were classified as high risk and should therefore be removed immediately. This was agreed to be done forthwith and a notice erected stating that they were in the process of being replaced. MM offered to let the Clerk have the correct catalogue details for ordering the new parts - some £80 per pair. A seat also needs replacing at a later date.
- The meeting agreed to remove the basketball net and slabs, which were also categorised as High Risk.
- The meeting further agreed to move the football goalpost to stop it wobbling.
- MM stated that he had concerns over the general condition of the junior swings with regard to internal corrosion.
- Seesaw he thought that the bearings needed replacing.

Palehouse Common

Again, MM has concerns over possible corrosion on the swings.

MM agreed to do some of the smaller, low/medium risk tasks on the list and was thanked for all his efforts.
