Minutes of an Environment Committee Meeting held on Wednesday, 12 October 2011, at 8 pm in the Memorial Hall, Framfield.

1. Apologies

2. Declarations of Interest

There were none.

3. Minutes of the last Meeting: 10 August 2011

It was agreed that the minutes of the last meeting held on 10 August 2011 having been circulated, be approved, adopted and signed as a correct record.

4. Matters Arising

- **Guideposts** – The Clerk reported she would contact Phil Anderson again and ask him to contact Maria Naylor regarding the post near to Brookhouse Lane. She would also report the post near Beechy Road, Blackboys. **ACTION: EC004 – CLERK.** The meeting agreed to discuss guidepost provision at the next FGP meeting.
- **Community Emergency Plan** – ongoing. **ACTION: EC005 – CLERK/FG.**
- **Blackboys traffic calming** – The Clerk reported that an update was given at the recent Parish Council meeting. The re-engineering works would be going ahead in January 2012 at the eastern end of Blackboys High Street. Michael Higgs was ‘tinkering’ with the traffic calming issue of the High Street and would bring it back to the PC at some point. **ACTION: EC006 – ongoing.**
- **Palehouse Common – request for speed reduction.** Chris Dowling is liaising with a resident who is very concerned at the speed and type of traffic using the road. The Clerk stated that she had asked WDC to request that Linden Homes stop using the ‘cut through’ for their spoil vehicles.
- **Lewes Road, Blackboys – petition.** There was no further update.
- **‘Roundabouts’** – The Clerk confirmed that ESCC have dealt with the grass triangle at the Sandy Lane junction but that she would be contacting them again regarding the same in Blackboys. **ACTION: 007 – CLERK.**

5. Any Other Business

- John Mordaunt asked the Clerk to report the condition of the stile into a field at the end of Green Lane, Blackboys. **ACTION: 008 – CLERK.**
- Streetlights – there were no reports from residents on the change in bulbs. Jeff Goggin stated that some of the lights in Becketts Way were off. He was asked to pass a list to the Clerk. **ACTION: 009 – CLERK/JG.**
