- Letter from the Framfield & Blackboys Horticultural Society asking for permission to use the recreation ground for the Summer Show on 13 August 2016. This was agreed.
- Letter from Share Access.Com. The Clerk explained that Shares Access Ltd represent two mobile telephone communications companies who wish to erect a mast at the rear of the recreation ground in Framfield. New legislation is coming in in 2017 where by operators will be fined up to 10% of their profit if areas do not receive appropriate mobile coverage Framfield is a low coverage area. The meeting agreed to have a public meeting to gauge opinion. ACTION: FF 014 CLERK.
- David Jenner asked if he could use the recreation ground for the Craig Baldock Memorial Match on 6 August 2016 plus use of the Hall, BBQ etc – the meeting had no objection but David was asked to liaise with Mary Short.

- Caretaker checklist. The meeting agreed that due to some recent damage etc in the Hall, a checklist would be drawn up for Brian's guidance when in particular non-regular users have vacated the Hall after a function. **ACTION: FF 018 ALL.**
 - Fire Risk Assessment. The Clerk reported that this was still to be done she would liaise with Brian. The decision could then be made whether to remove all but the

kitchen fire extinguisher. Although they are to be tested as usual this year. **ACTION:** FF 019 – CLERK/BS.

 Hall bookings - Graham Pope queried if regular local user requirements should/could be given priority over non-Parish bookings even if they are regular and more frequent. The meeting agreed that the main priority of the Hall had to be financial security and therefore security of bookings with frequent, regular users.
