- WD/2017/0337/F The demolition of the existing redundant farm buildings and in replacement the construction of a new three bedroom house, complete with new drainage system.
 Framfield Farm Barn, Etchingwood Lane, Framfield TN2 5QH.
 The applicants put forward their case for a home on the site.
 The Parish Council supports the application but would like Planning Officers to look into the ecology identified in the ecological survey to make sure that it is adequately addressed along with a thorough solution for the foul drainage which seems to have been omitted from the details.
- WD/2017/0279/F Erection of a single storey link extension and conversion of existing outbuilding to sitting room and utility.
 Oak Tree Farm, Lewes Road, Blackboys TN22 5JL.
 The Parish Council supports this application for a minor addition to the property making good use of an existing out-building.
- WD/2017/0358/F Creation of off road parking and turning space using existing highway access.
 Old Pound Farm, Pound Lane, Blackboys, TN22 5RT.
 The Parish Council supports the application subject to the views of ESCC on the safety of the enhanced access.

 WD/2017/0467/F – 2 bay open car port/garage with concrete hardstanding. Oak timber frame, tiled roof with two barn hips at either end.

Baytrees, Gatehouse Lane, Framfield TN22 5RS.

The Parish Council supports the principle of a new garage but has concerns over the size, particularly the height of these proposals.

 WD/2017/0558/F – Change of use of first floor of outbuilding from domestic use to holiday accommodation.
 Gunbanks Farm, Blackboys TN22 5HS

The Parish Council supports the application which will have a minimal impact on the surrounding area and is a good re-use of an existing building.

 WD/2017/0584/F - Proposed garage conversion and extension to form a self-contained annexe and new replacement garage.
 Acre Mead, Framfield Road, Blackboys TN22 5LR

The Parish Council objects to this application on the grounds of over development of the site. The proposed annexe is too large and the relocation of the new garage is too near to the main road by virtue of its height which will be clearly visible in the street scene.

• WD/2017/0567/F - Land opposite 2 Ivy Cottages, Hammonds Green, Framfield TN22 5HB.

Sand School – Equestrian use.

The Parish Council supports the application providing that a condition is attached and enforced that the sand school should be for private use, ie non-commercial use, only.
